# Terms & Conditions

### JUMPER MUST FIT FOLLOWING CRITERIA:

- Must be between the ages of 18 years old and 65 years old.
- Must weigh less than 220lbs (100kg).
- Must not have been Scuba Diving (or other ocean diving activities) within 24 hours prior to jump.
- Must not be under the influence of alcohol and/or narcotics.
- Must not be pregnant.
- Must not be under any exercise restrictions or have any major health problems. (Please contact us before you book if you have a Hernia or Epilepsy)
- Skydive will cooperate with infection prevention measures for simultaneous epidemics such as the new coronavirus and seasonal influenza. If you have a fever or other symptoms of the new coronavirus or do not cooperate with the procedures, we may refuse your right to participate in the tour.

**Note:** If a jumper does not fit the criteria above, there will be a cancellation charge if a reservation had been made.

### **CANCELLATION POLICY:**

More than 48 hours before reservation: 100% refund. This is in the amount of the price paid charged at time of booking.

Within 48 hours of reservation: 50% refund. Example: For 8k Tandem Jump you will get \$149.50 back.

Within 24 hours of reservation: No refund.

**Injury or sickness:** 100% refund with a valid doctor's note presented to reservation staff.

**Weather:** If the weather is bad we will do our best to reschedule you. There is no cancellation fee if you are not able to jump. You will be fully refunded if you are unable to be rescheduled.
